ARTIST OBLIGATIONS

4. The Artist represents and warrants that he/she has created the Artwork, and that each piece does not violate any copyright and/or laws.

GALLERY OBLIGATIONS

- 5. The Gallery shall be responsible for cleanliness and good care of the Artwork for the duration of the Agreement. If unrepairable damage is made to the Artwork by the Gallery or those for whom the Gallery is in law responsible, the Gallery shall be responsible for the retail price as noted on the attached List of Artwork (less the Gallery's commission) for the damaged Artwork.
- 6. If no sale of the Artwork is concluded prior to termination of this Agreement, the Artwork shall be made available for pick-up by the Artist in the same state it/they was/were when first delivered.

DURATION AND TERMINATION OF CONSIGNMENT

7. The initial term of this Agreement shall continue until <u>Saturday May 16th, 2020 at 4pm,</u> and the Artist shall not ask for return of the Artwork prior to that date. Thereafter, the artist is responsible for pick up of Artwork un-sold. <u>The Gallery is not responsible for the Artwork left at the Gallery past the date of Saturday May 23rd at 4pm, 2020.</u>

Should the artwork not be accepted, the Artist is responsible for pick up of Artwork by Tuesday, April 28th, 2020
